Rules:

- **All Ocean State Artisan members must be in good standing with Ocean State Artisans by 10/15/2022 to get the discounted show fee.**
- Every exhibitor must have a valid email address where they can receive upcoming fair information. There will be no other form of communication going forward other than by email.
- Every new exhibitor must submit three (3) photographs of products and a photograph of your booth with their application.
- No exhibitor may dismantle or leave prior to the advertised closing hour. This is a **3-day show**, if you leave earlier, you will not be asked to come back next year.
- All items for sale must be **HAND CRAFTED Original Designs** by the exhibitor. No repackaging is allowed.

Please initial all statements below

I _____ understand that if there are any items in my booth that are not Original Designs or Hand Crafted by the Artist or Crafter you will be asked to immediately remove them from the building. There will be **NO** manufactured or repackaging of items allowed in Ocean State Artisans Holiday Craft Show.

I _____ will attach a list of items to be shown in my booth and attach it to the application. If you have any new product or art, you must send a picture to the committee.

- You must provide your own tables, chairs, and table covers to the ground.
- Exhibitors must stay within their assigned space and keep their area clean. Exhibitors must leave their space spotless when breaking down.
- You must be able to enter and exit your booth within your assigned space.
- Setup must be done on Wednesday November 23, 2022. Assigned times will be sent out to you by Monday- November 21,2022.
- **Sales Tax:** Each exhibitor must have a current Rhode Island Retail Sales Permit. Any exhibitor who does not have one (or has one but fails to provide their sales tax number), will be required to purchase a temporary one before setting up. The form will be available at the show, \$10.00 fee, made payable by check to RI Division of Taxation.
- Exhibitors who do not have a RI Certificate of Exemption for Artistic Works may sell qualifying works of art tax free under the Ocean State Artisans sales tax exemption so long as they comply with the reporting requirements procedure.
- PayPal will be excepted for payment with a \$5.00 processing fee.
