Why you are receiving this notice

You are receiving this notice because of your interest in the 2026 Ocean State Artisans 35th Annual Holiday Market and Food Drive. As an Artisan, this is your invitation to pre-register.

The Show dates are Friday, November 27, Saturday, November 28, & Sunday, November 29, 2026.

The Show times will be determined at a later date

What you need to do

This is a juried event. You must pre-register for the 2026 OSA Holiday Market and Food Drive **prior to March 1, 2026**, by emailing these specific requirements listed below to OSAholidaymarket@gmail.com. Please add "PRE-REGISTRATION JURY SUBMISSION 2026" in the subject line. *Note: All Artisans and returning Artisans must pre-register to be considered for the 2026 show. No payment is due at this time.*

Your email must include the following for 2026 pre-registration submission:

1. Contact information. First/Last Name, Business Name, Email, Cellphone, and Address.
2. Display size. What size booth spaces are you interested in? See chart on next page.
3. Display set up & pictures of your work. Send a .pdf of your indoor booth display that showcases your creative setup. Send a .pdf of your best 5-10 pictures of your work. With completion of this contract, you give permission to use your pictures for show advertisement purposes.
4. Category selection. To ensure we have a completely diverse array of Artisans with a select number of offerings in each category, please list the best category or categories that best describes your work.
 - ❖ 3D – original designs produced using a 3D machine
 - ❖ Art – canvas artwork, tiles, painted artwork, chalked artwork, sketched pencil artwork, eggshell artwork, etc.
 - ❖ Body Art – temporary tattoos, henna, face painting, etc.
 - ❖ Books/Paper – original author/illustrator, cards, journals, paper art, layered shadow boxes, handcrafted pens/pencils
 - ❖ Boutique – ornaments, tree toppers, holiday décor, home décor, handbags, headbands, hair bows, mixed media, etc.
 - ❖ Candles – soy, coconut wax, beeswax, essential oils in candles, etc.
 - ❖ Clay - sculptures, faux food created from clay, clay art, decorative clay pieces, etc. (not pottery)
 - ❖ Clothing – hand painted, SVG/sublimation personally designed image on clothing, tie dyed, sewn pattern, upcycled, etc.
 - ❖ Crystals – any items using crystals as the main feature
 - ❖ Fabric – handsewn, machine sewn, embroidery, holiday décor, quilts, pillows, blankets (not clothing)
 - ❖ Food – honey, perishables, jarred, pickles, preserves, spices, baked goods, chocolates, sauces, etc.
 - ❖ Footwear – slippers, shoes, boots, etc.
 - ❖ Glass – stained glass, blown glass, sea glass, artwork using glass (not jewelry)
 - ❖ Jewelry – glass, acrylic, fabric, resin, metal, leather, porcelain, feather, rope, wire, etc.
 - ❖ Leather - any items using leather as the main feature
 - ❖ Metal – sculptures, wire art, etc. (not jewelry)
 - ❖ Music – instruments, song books with your original lyrics, original recordings of your music, etc.
 - ❖ Pets – gourmet original recipe food/treats, leashes, collars, clothing, toys, etc.
 - ❖ Photography – any items using photography as the main feature
 - ❖ Pottery – food-grade, decorative, painted, etc.
 - ❖ Resin – any items using resin as the main feature
 - ❖ Sacred Items – dream catchers, spiritual items, etc.



- ❖ Sublimation –original designed images on a mug/tumbler/coaster/signs/mobiles (not clothing), etc.
- ❖ Toys – original designs, handmade, etc.
- ❖ Wellness – hot/cold packs, herbal remedies, essential oils, lotions, perfume, soaps, etc.
- ❖ Wood – any items using wood as the main feature
- ❖ Wreaths – flower, pine, pinecone, fabric, shells, etc.
- ❖ Yarn – knit, crochet, macrame, etc.
- ❖ Miscellaneous – please describe your item(s) if none of the above categories represents your work

Electricity 110 volt - one price, all 3 days, regardless of booth size – strongly encouraged so that you can add additional lighting to highlight your work.	\$50 additional
